STAGE 1 – General (everyday hygiene and procedures)	None	 General reminders for hygiene Effective handwashing facilities and soap available Follow usual absence periods for sickness Parental/staff contact details are updated at least annually Enforce use of sanitiser by every person who comes through the doors at school. Anti bacterial wipes in every classroom – students wipe down where they've been sitting after every lesson Use clear plastic folders for every student in every classroom. These folders are to contain pens and books used exclusively by the individual All staff to undergo lateral flow testing at least once a week All pupils recommended to take lateral flow testing similarly 	All people in the building	HANDS • wash hands regularly and thoroughly for at least 20 seconds FACE • wear face coverings in enclosed spaces where you can't keep your distance. Face coverings should be worn by adults (staff and visitors) and pupils when moving around indoors in corridors and communal areas where social distancing is difficult to maintain. SPACE • stay 2 metres apart from people you do not live with where possible, or 1 metre with extra precautions in place (such as wearing face coverings).
